Chairman's Message



"Change is the only constant in life". This quote is attributed to the Greek philosopher Heraclitus. Although the quote was originated centuries ago, it remains quite

relevant today, especially in the health care field. The medical literature is replete with studies examining practices that may or may not have a firm basis in good evidence, and we must always be willing to alter our practices in the light of carefully derived and confirmed new evidence. Even on an individual level, we must always be careful not to fall prey to confirmation bias that can prevent us from fully considering the different diagnoses that may be responsible for a given patient's symptoms. As I have suggested before in this space, humility is an essential component to being a good physician. Winston Churchill said, "To improve is to change; to be perfect is to change often." As physicians, we are always striving to improve our performance, to approach perfection in our work. Change is the vehicle by which we achieve such growth.

Change is also constant on an organizational level, so it is important that we all become more comfortable with the transitions inherent in academic medical center operations. This past year has been particularly rich with change. At the Medical School, we have welcomed Dean of Medicine and Biological Sciences Mukesh Jain as well as several Associate Deans, including Pat Poitevien, formerly Director of the Pediatric Residency Program at Lifespan, as the Inaugural Senior Associate Dean of Diversity, Equity and Inclusion and Brittany Star Hampton, former Interim Chair of the Department of Obstetrics and Gynecology, as the Senior Associate Dean for Medical Education. Timothy Babineau has stepped down as the CEO of the Lifespan Health System and Jim Fanale has announced he will be stepping down as CEO of Care New England. Within our own program, we have welcomed a new Internal Medicine House Staff Program Director, Rachel Simmons, replacing long-time Director Dom Tammaro, who will be taking a broader view of our Departmental Educational Programs as the Vice Chair of Education. I am also thrilled that Karen Tashima of our Infectious Diseases Division has taken on the responsibilities of Vice Chair of Faculty Affairs. Our Fellowship Directors have seen several recent changes in their roster - our new directors include Marcella Aquino in Allergy & Immunology, Kate French in Cardiology, Omar Hyder in Interventional Cardiology and Jensy Stafford in Palliative Care. And of course, we have welcomed five new Chief Residents, a new group of interns, and have bid farewell to last year's group of senior residents.

Whew! How are we to manage in the face of all this change?

First, it is important to understand that all our institutions have their own cultures that tend to persist despite changes in leadership. Institutions with positive cultures can take comfort in the fact that cultural change is difficult to accomplish. It is my view that we have a very positive culture within the Department of Medicine. Our faculty are deeply committed to education, research and providing the highest quality of care to our patients. Our house staff share these attributes and add a remarkable eagerness to teach and support each other, a feature that is a hallmark of our program. I have often said that learning to become a physician is necessarily hard - it is hard physically, intellectually,

Tashima Appointed Vice Chair for Faculty Affairs



Karen Tashima, M.D. was recently appointed as the Vice Chair for Faculty Affairs in the Department of Medicine.

Dr. Tashima is a Professor of Medicine in the Division of Infectious Diseases at the Warren Alpert School of Medicine at Brown University. She received her undergraduate degree in Biochemical Science at Harvard-Radcliffe University and her medical degree from Columbia University School of Physicians and Surgeons. She trained in Internal Medicine at New York-Presbyterian Hospital and in Infectious Diseases at Massachusetts General Hospital. In 1995, she joined the Infectious Disease Division at Brown. She has directed the HIV Clinical Trials program since 1998, helping to establish modern day highly effective and well tolerated HIV therapy. She serves as Chair of Lifespan IRB at The Miriam Hospital. Dr. Tashima was the ID fellowship director

from 2005-2012 and is Director of HIV Research in the Division. She has served on the Department of Medicine's Promotion Committee since 2017, and was awarded the Charles CJ Carpenter Physician of the Year Award by The Miriam Hospital Medical Staff Association in 2021 for her efforts in responding to the COVID-19 pandemic.

Her duties as Vice Chair for Faculty Affairs will include chairing the **Departmental Promotions Committee** as well as focusing on a range of areas important to the growth and retention of our faculty. These will include developing and updating standards and practices for recruitment of new faculty, orienting new faculty after their arrival. monitoring, and advising faculty on progress toward and timeline of promotions, faculty development/ mentoring/engagement, overseeing Departmental programs in Diversity, Equity and Inclusion, all in close association and collaboration with leadership and relevant committees at the Warren Alpert Medical School. -

Mermel Receives Lifetime Achievement Award



Leonard Mermel, D.O., medical director of Lifespan's epidemiology and infection control department, has received the 2021 Milton Hamolsky

Lifetime Achievement Award from the Rhode Island Chapter of the American College of Physicians. The award recognizes both his contributions to the field of infection control and epidemiology and his overall excellence and professionalism in the practice of medicine.

"I am honored to be the recipient of the Hamolsky Lifetime Achievement Award, and most fortunate to have known Dr. Hamolsky and his tremendous contributions to our medical community," said Dr. Mermel. "During my 30-plus years at Lifespan, my work has been focused on enhancing the quality and effectiveness of healthcare delivered to the patients who we are honored to serve."

Over the last two years, Dr. Mermel has been a steady public face of Lifespan's COVID-19 response, sharing his expertise with a variety of local and national media outlets. He has coauthored over 350 articles, textbook chapters, and abstracts on infection control and infectious diseases, as well as US guidelines on prevention and management of intravascular catheter infections.

The Milton Hamolsky Lifetime Achievement Award is presented annually to a senior College member whose excellence epitomizes the attributes of the award's namesake, Dr. Milton Hamolsky. and emotionally — but it does not have to be obnoxious. The support I see our house staff offering each other and their student trainees is immensely gratifying to me, and an essential characteristic of our program that I believe should never change. I am confident that all the new leaders who have joined our programs share this view and all those existing faculty who remain in their educational roles will continue to have a positive influence on our training community.

We must also be aware that there are aspects of any culture that can inhibit our ability to move forward as an academic medical center and we should be open to changes that will help us to grow. We need to continue our emphasis on improving our Diversity, Equity, and Inclusion efforts to make the environment in all our hospitals and practices welcoming and comfortable for individuals of all races, ethnicities, genders, sexual orientations, and schools of thought. We need to continue to place emphasis on the wellness of all with whom we work, especially after the significant toll taken on us all by the sequential surges of the Covid-19 pandemic. We need to organize our practices in a way that optimizes access, convenience and quality for patients and maximizes the efficiency of our education and research. Efforts are ongoing to bring the research efforts of Brown, Lifespan and Care New England together under one umbrella. It is critical that these efforts are successful, and I urge all parties to be flexible and to be willing to make the necessary sacrifices which will lead to successes that, together, will be greater than the simple sum of the individual parts.

The future of high-quality, tertiary health care in the state of Rhode Island is not guaranteed — a fact which could threaten the well-being, not only of our patients, but of our research and educational missions as well. I urge all of us to be open to the efforts, plans, and ideas of our leaders (new and established) to affect the types of changes that will ensure world class health care for the citizens of Rhode Island for decades to come. It's an honor to serve our organization at such a time of exciting change and opportunity.

Graff Honored with Innovator Award



Stephanie L. Graff, M.D., FACP, of the Division of Hematology and Oncology, received the Woman Disruptor of the Year award, which goes to a woman

in the field who has emerged as a leader and an example to younger women of how a successful career can unfold. The awardee may have a career of positive disruption or more recent advancements through which she has made a positive impact within the specialty.

The award was presented during the ASCO Annual Meeting held in June during a ceremony in conjunction with Healio honoring the inaugural "Healio Disruptive Innovators in hematology/oncology."

Graff, who serves on Healio's Women in Oncology Peer Perspective Board, made big moves this year in her career and for the oncology community.

Graff recently moved to Lifespan Cancer Institute at Brown University where she is taking on a more academic role than in the past, while remaining involved in patient care.

Highlights of her career so far include work as a principal investigator on trials that resulted in new approvals like Impassion130, which led to the first FDA approval of a targeted therapy and an immunotherapy for breast cancer — and being part of the ASCO Leadership Development Program, during which she worked with a team on a professionalism initiative.

This year, Graff gave talks on collaborating with community providers for program success and how Implicit Bias impacts our teams and our patients. Her published work this year included data on sexual harassment in the oncology workplace.

She is committed to creating a culture of inclusion and equity in medicine; driving and designing clinical research that better represents the faces of persons at risk and/or diagnosed with cancer; and continuing to improve access to care.

"Change is always good," Graff told Healio. "If it feels easy or too accessible, maybe it's not enough of a challenge."

For women in oncology considering career moves, she said that "doors are always open."

"Women in general can sell themselves short and think opportunities are out of their reach," she said. "I would encourage them to think bigger of themselves and to look for opportunities that will be a challenge and cause them to step into something that will present opportunities for growth." •

Brandon del Pozo Hired as Research Scientist



Dr. Brandon del Pozo, Ph.D., MPA, MA, joined the Division of General Internal Medicine at Rhode Island Hospital as a Research Scientist in May of 2022, with corresponding appointments at Brown

University as an Assistant Professor of Medicine, and Health Services, Policy, and Practice (Research). Dr. del Pozo conducts NIH-funded research at the intersection of public health, public safety, and justice, focusing on substance use and the overdose crisis. Prior to research, he served as a police officer for 23 years. Nineteen were spent in the New York City Police Department, where he started on patrol in East Flatbush, Brooklyn, went on to command two patrol precincts, and served in the police commissioner's office. He also spent four years as Chief of Police of Burlington, Vermont, where he directed the city's interdisciplinary response to the opioid crisis. His efforts were associated with a substantial and sustained reduction in opioid overdose deaths. He was the 2016 recipient of the Police Executive Research Forum's Gary Hayes Award for excellence in police leadership, and his popular writing has been featured in The New York Times, The Washington Post, The Philadelphia Inquirer, and the New York Daily News. Dr. del Pozo's book, The Police and the State: Security, Social Cooperation, and the Public Good, is in production at Cambridge University Press. He earned a PhD from the City University of New York Graduate Center, an MPA from Harvard University, an MA from John Jay College, and a bachelor's degree from Dartmouth.
